A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KING JAMES ENTERPRISES FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE SUPPLIES FOR THE FABRICATION OF LARGE FUNNEL
