A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LIFERICH CONSOLIDATED CORPORATION (CONCOURSE II) FOR THE MEALS & VENUE FOR THE TRAINING ON HOME CARE SUPPORT SERVICES FOR SENIOR CITIZENS

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:




