A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS AND ACCESSORIES FOR THE REPAIR AND MAINTENANCE OF VEHICLE WITH PLATE NO./CONDUCTION STICKER SKE-759 (GSO), DOB-664 (CENRO) AND HYUNDAI BACKHOE (WHEEL TYPE)
