A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KING JAMES ENTERPRISES FOR THE SUPPLY & DELIVERY OF POWER SPRAYER PRESSURE WASHER FOR MAINTAINING CLEANLINESS OF VARIOUS VEHICLE, BUILDINGS AND EQUIPMENT OWNED BY THE CITY GOVERNMENT OF TABACO

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-07-0903** with an Approved Budget for the Contract (ABC) of **Php 115,000.00**
