A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR THE JO-LABOR, EQUIPMENT RENTAL AND MATERIALS FOR THE IMPROVEMENT OF CITY HALL ANNEX BUILDING AT CITY ENGINEERING OFFICE AT TABACO CITY HALL ANNEX BUILDING, QUINALE-CABASAN, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-07-0950** with an Approved Budget for the Contract (ABC) of **Php 333,901.00**
