A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO RED HOG AGRO INDUSTRIES FOR THE SUPPLY & DELIVERY OF PURPLE SWEET CORN SEEDS FOR CORN FARMERS OF TABACO CITY
