A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JYQ ENTERPRISES FOR THE JO-LABOR & MATERIALS FOR THE GENERAL BODY REPAIR, REPAINTING AND ELECTRICAL REPAIR FOR DUMP TRUCK WITH PLATE NO. SAB-5050 (TCE-02) OF CITY ENVIRONMENT & NATURAL RESOURCES OFFICE (CENRO)
