**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR THE JO-LABOR & MATERIALS FOR THE FABRICATION OF 6 UNIT STEEL BARRIER FOR CADAC OFFICE, BRGY. PAWA, TABACO CITY**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-08-1105** with an Approved Budget for the Contract (ABC) of **Php 66,335.00**
