**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MMC MARKETING FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE CONSTRUCTION OF CONJUGAL ROOM IN BJMP TABACO AT SAN LORENZO, TABACO CITY**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 23-08-1108** with an Approved Budget for the Contract (ABC) of **Php 214,375.00**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a) To award the contract to **MMC MARKETING** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
