A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF VARIOUS ELECTRICAL MATERIALS AND SUPPLIES FOR THE IMPROVEMENT AND RESTORATION OF TRANSFORMER ACCESSORIES, SAN ANTONIO LYING-IN CLINIC AND SAN CARLOS STREET LIGHTS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-09-1131** with an Approved Budget for the Contract (ABC) of **Php 211,050.00**
