A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO E.C. PEST CONTROL SERVICES FOR THE PEST CONTROL SERVICES FOR ALL OFFICES IN TABACO CITY HALL MAIN BUILDING

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-09-1137** with an Approved Budget for the Contract (ABC) of **Php 66,043.20**

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Joseph Pest Control Services was found to be non-compliant with the requirements of the project. Its bid was not duly signed and the unit price was not indicated. Hence it was disqualified.

WHEREAS, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, E.C. Pest Control Services, and it was found to be responsive with the requirements of the project.


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
