**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JS ZAMORA CONSTRUCTION FOR THE JO-LABOR, EQUIPMENT RENTAL AND MATERIALS FOR CONSTRUCTION OF MOTORPOOL BUILDING, PHASE II AT BRGY. PAWA, TABACO CITY**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-09-1188** with an Approved Budget for the Contract (ABC) of **Php 595,648.00**
