**Invitation to Bid for  
Rehabilitation of Various Roadways, Various Barangays, Tabaco City  
Contract ID No. 006-02-2024-INFRA-PB**

1. The *City Government of Tabaco*, through the *20% CDF 2024*, intends to apply the sum of *Forty-Nine Million Five Hundred Thousand Pesos (Php 49,500,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Rehabilitation of Various Roadways, Various Barangays, Tabaco City under Contract ID No. 006-02-2024-INFRA-PB*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *City Government of Tabaco* now invites bids for the above Procurement Project. Completion of the Works is required *within 240 calendar days from receipt of Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the *City Government of Tabaco* and inspect the Bidding Documents at the address given below from *9:00 A.M. to 4:00 P.M.*
5. A complete set of Bidding Documents may be acquired by interested bidders on *February 20, 2024-March 12, 2024* from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents*, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Twenty-Five Thousand Pesos (P25,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The *City Government of Tabaco* will hold a Pre-Bid Conference on *February 28, 2024, 10:30AM, BAC Conference Room, 2F Annex Bldg., Tabaco City Hall, Tabaco City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *9:00AM, March 12, 2024*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on *March 12, 2024, 9:30AM* at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
