A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SCL POZO NEGRO EXCAVATOR AND PLUMBING SERVICES FOR THE JO-LABOR & MATERIALS FOR THE MAINTENANCE OF TERMINAL BUILDING II SIPHONING OF SEPTIC TANK SLUDGE AT TERMINAL BUILDING II, TCCT COMPLEX, BRGY. PAWA, TABACO CITY
