A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JS ZAMORA CONSTRUCTION FOR THE JO-LABOR & MATERIALS FOR THE REPAIR AND MAINTENANCE OF UPLAND AND SAN MIGUEL ISLAND, TABACO CITY WATER SYSTEM
