A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS FOR VEHICLE WITH PLATE NO./CONDUCTION STICKERS SGK-298 (GSO) AND SAB-6215 (CDU) AND PATROL BOAT (AGRI-FISHERIES)
