A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GEN. MDSE. FOR THE SUPPLY & DELIVERY OF DRUGS AND MEDICINES
