A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION AND SUPPLY FOR THE JO-LABOR, MATERIALS AND EQUIPMENT FOR THE REHABILITATION OF LINE CANAL AND CONTINUATION OF CONSTRUCTION OF LINE CANAL COVER AT PUROK 6 MATAGBAC, TABACO CITY
