A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KRFIKA GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF FOOD INGREDIENTS FOR THE FEEDING SUPPLEMENTATION FOR UNDERNOURISHED PRE-SCHOOL CHILDREN
