A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MMC MARKETING FOR THE SUPPLY & DELIVERY OF ELECTRONIC KILOWATT-HOUR METER FOR INSTALLATION AND TEMPORARY HOUSING SUB-METERS, SAN VICENTE, TABACO CITY
