A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JS ZAMORA CONSTRUCTION FOR THE JO-LABOR, EQUIPMENT RENTAL AND MATERIALS FOR THE PERIMETER FENCE AT DISASTER OPERATION CENTER AT DOC, PAWA, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Small Value Procurement under Section 53.9 of the IRR-RA 9184 as the mode of procurement for Purchase Request 23-08-1047 with an Approved Budget for the Contract (ABC) of Php 404,798.00
