A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PLC TRADING INC. FOR THE SUPPLY & DELIVERY OF MULTIVITAMIN DROPS AND SYRUP FOR THE PROVISION OF MULTIVITAMINS (MICRONUTRIENT SUPPLEMENTATION)
