A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS AND ACCESSORIES FOR MOTORPOOL SUPPLIES AND REPAIR MAINTENANCE OF VARIOUS VEHICLE OWNED BY THE CITY GOVERNMENT OF TABACO
