A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CPQ COMPUTER CENTER FOR THE SUPPLY & DELIVERY OF PRINTER

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request 23-08-1074 with an Approved Budget for the Contract (ABC) of Php 55,000.00

WHEREAS, the BAC has posted in the PhilGEPs website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

WHEREAS, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, CPQ Computer Center, and it was found to be responsive and compliant with the minimum specification of the project.

- a.) To award the contract to **CPQ Computer Center** as the Supplier with the the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b.) To recommend to the City Mayor of Tabaco the award of contract to **CPQ Computer Center** in the amount of **Fifty Four Thousand Six Hundred Pesos (Php 54,600.00)**
