A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR FOR THE SUPPLY & DELIVERY OF LAPTOP COMPUTER AND DESKTOP COMPUTER

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request 23-08-1097 with an Approved Budget for the Contract (ABC) of Php 140,000.00

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

- b.) To recommend to the City Mayor of Tabaco the award of contract to **Albay Computer & Electronics Supplies & Repair** in the amount of **One Hundred Thirty Nine Thousand Four Hundred Ninety Five Pesos** [Php 139,495.00]
