A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JAMESTOWN BUILDERS & CONSTRUCTION SUPPLIES FOR THE JO-SUPPLY, LABOR AND MATERIALS FOR THE REPAIR/IMPROVEMENT OF TEMPORARY OFFICE AT TAMBAKAN, BRGY. QUINALE-CABASAN, TABACO CITY
