A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SAN CARLOS HARDWARE OPC FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE MATERIALS AND SUPPLIES FOR THE REPAIR/REHAB OF BUILDING AND OTHER STRUCTURES AT VARIOUS BRGY. AT TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-09-1129** with an Approved Budget for the Contract (ABC) of **Php 299,655.00**
