**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT & CONSTRUCTION FOR THE SUPPLY & DELIVERY OF SAFETY SUPPLIES FOR OPERATION AND MAINTENANCE WORKS OF CENRO PERSONNEL FOR GARBAGE COLLECTION, HANDLING AND PROCESSING**
