BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO JAG-VAIL CONST. AND SUPPLY & MARZAM CONST. AND SUPPLY (JV) FOR THE CONSTRUCTION/ REHABILITATION/REPAIR OF SCHOOL BUILDINGS AT UPLAND BARANGAYS, VARIOUS UPLAND BARANGAYS, TABACO CITY CONTRACT ID NO. 001-01-2024-INFRA-NP-A/C

WHEREAS, the Bids and Awards Committee (BAC) has adopted **Negotiated Procurement (Adjacent/Contiguous Contract)** as the mode of procurement for the **Construction/ Rehabilitation/Repair of School Buildings at Upland Barangays, Various Upland Barangays, Tabaco City, Contract ID No. 001-01-2024-INFRA-NP-A/C** under **Purchase Request No. 24-01-0001** with an Approved Budget for the Contract (ABC) amounting to **One Million Seven Hundred Thousand Pesos (Php 1,700,000.00)**;

WHEREAS, the BAC directly negotiated with **Jag-Vail Const. and Supply & Marzam Const. and Supply (JV)**, the contractor for the ongoing contract **Cluster 3-Construction/ Rehabilitation/ Repair of School Buildings at Upland Barangays, Various Upland Barangays, Tabaco City** under **Contract ID No. 005-02-2023-INFRA** which is adjacent or contiguous to the foregoing contract;

WHEREAS, **Jag-Vail Const. and Supply & Marzam Const. and Supply (JV)** had accepted the negotiation and offered to execute and complete the project at a contract price amounting to **One Million Six Hundred Sixty-Three Thousand Five Hundred Seventy-One Pesos and Seven Centavos (Php 1,663,571.07)**;

WHEREAS, upon detailed evaluation of its bid, the BAC found that the contractor used the same prices or lower unit prices as in the original contract less mobilization cost;


WHEREAS, upon ascertainment of compliance with the requirements of the project, the BAC find the offer of **Jag-Vail Const. and Supply & Marzam Const. and Supply (JV)** to be responsive and the most advantageous price to the government;

NOW, THEREFORE, in the light of the foregoing considerations, We, the members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend for approval by the City Mayor, **CIELO KRISEL LAGMAN-LUISTRO**, the award of the foregoing contract to **Jag-Vail Const. and Supply & Marzam Const. and Supply (JV)** at a contract price amounting to **One Million Six Hundred Sixty-Three Thousand Five Hundred Seventy-One Pesos and Seven Centavos (Php 1,663,571.07)**.
