**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO STEVEN CONST. AND SUPPLY / OMEGA CONTRACTING AND DEV'T CORP. (JV) FOR THE CONSTRUCTION/ REHABILITATION/ REPAIR OF SCHOOL BUILDINGS AT ISLAND BARANGAYS, SAN MIGUEL ISLAND, TABACO CITY CONTRACT ID NO. 003-01-2024-INFRA-NP-A/C**

**WHEREAS**, the Bids and Awards Committee (BAC) has adopted **Negotiated Procurement (Adjacent/Contiguous Contract)** as the mode of procurement for the **Construction/ Rehabilitation/ Repair of School Buildings at Island Barangays, San Miguel Island, Tabaco City, Contract ID No. 003-01-2024-INFRA-NP-A/C** with an Approved Budget for the Contract (ABC) amounting to **Eight Hundred Thousand Pesos (Php 800,000.00)**;

**WHEREAS**, the BAC directly negotiated with **Steven Const. and Supply / Omega Contracting and Dev't Corp. (JV)**, the contractor for the ongoing contract **Cluster 1-Construction/ Rehabilitation/Repair of School Buildings at Island Barangays, San Miguel Island, Tabaco City under Contract ID No. 003-02-2023-INFRA** which is adjacent or contiguous to the foregoing contract;

**WHEREAS**, **Steven Const. and Supply / Omega Contracting and Dev't Corp. (JV)** had accepted the negotiation and offered to execute and complete the project at a contract price amounting to **Seven Hundred Ninety-Nine Thousand Nine Hundred Forty Pesos and Thirty Centavos (Php 799,940.30)**;

**WHEREAS**, upon detailed evaluation of its bid, the BAC found that the contractor used the same prices or lower unit prices as in the original contract less mobilization cost;

**WHEREAS**, upon ascertainment of compliance with the requirements of the project, the BAC find the offer of **Steven Const. and Supply / Omega Contracting and Dev't Corp. (JV)** to be responsive and the most advantageous price to the government;

**NOW, THEREFORE**, in the light of the foregoing considerations, We, the members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend for approval by the City Mayor, **CIELO KRISEL LAGMAN-LUISTRO**, the award of the foregoing contract to **Steven Const. and Supply / Omega Contracting and Dev't Corp. (JV)** at a contract price amounting to **Seven Hundred Ninety-Nine Thousand Nine Hundred Forty Pesos and Thirty Centavos (Php 799,940.30)**
