#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO COTTON CITY MARKETING CORP. FOR THE SUPPLY & DELIVERY OF T-SHIRT FOR THE 2024 NATIONAL WOMEN’S MONTH OPENING CELEBRATION
