A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CPQ COMPUTER CENTER FOR THE SUPPLY AND DELIVERY OF DESKTOP COMPUTER FOR MAINTENANCE SECTION, CITY ENGINEERING OFFICE, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-03-0137** with an Approved Budget for the Contract (ABC) of **Php 65,000.00**;
