A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PRECIOUSTAR CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF VARIOUS MATERIALS AND SUPPLIES FOR JANITORIAL SUPPLIES
