A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PRECIOUSTAR CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF VARIOUS JANITORIAL SUPPLIES

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


