A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JRE AGRIVET SUPPLY FOR THE SUPPLY AND DELIVERY OF ANTI-RABIES VACCINE FOR RABIES PREVENTION/DOG VACCINATION

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


