#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARAL LAMPARA AT MUSIKA SOUND SYSTEM SERVICES FOR THE RENTAL OF SOUNDS AND LIGHTS WITH LED WALL, ACRYLIC STAGE AND ROOFING
