A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO 3RB CONSTRUCTION & SUPPLY FOR THE CONSTRUCTION/ REHABILITATION AND IMPROVEMENT OF VARIOUS INFRASTRUCTURE PROJECTS (PUBLIC BUILDINGS & OTHER INFRASTRUCTURE), VARIOUS BARANGAYS, TABACO CITY UNDER CONTRACT ID NO. 010-04-2024-INFRA-PB

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Construction/ Rehabilitation and Improvement of Various Infrastructure Projects (Public Buildings & Other Infrastructure), Various Barangays, Tabaco City under Contract ID No. 010-04-2024-INFRA-PB*, with an Approved Budget for the Contract (ABC) amounting to *Forty-Eight Million Seven Hundred Eighty-Two Thousand One Hundred Thirty-Four Pesos and Two Centavos (Php 48,782,134.02)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, twelve (12) contractors had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on May 13, 2024, the BAC received eleven (11) bids;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:



WHEREAS, per post-qualification conducted by the BAC Technical Working Group (TWG) involving the verification and validation of legal, technical and financial documents of the bidder with lowest calculated bid, **3RB Construction & Supply** was found to be substantially compliant with the requirements of the said procurement and its bid has been found to be responsive;


NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of **3RB Construction & Supply** as the Lowest Calculated Responsive Bid (LCRB) for the **Construction/ Rehabilitation and Improvement of Various Infrastructure Projects (Public Buildings & Other Infrastructure), Various Barangays, Tabaco City under Contract ID No. 010-04-2024-INFRA-PB**; and
- b) To recommend to the City Mayor of Tabaco the award of contract to **3RB Construction & Supply** in the amount of **Forty-Seven Million Three Hundred Nineteen Thousand One Hundred Twenty-Two Pesos and Forty-Eight Centavos (Php 47,319,122.48)**.


