A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO RRS MARKETING CORPORATION FOR THE SUPPLY & DELIVERY OF SPLIT TYPE AIRCON

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


