A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PALANCA PRINTING PRESS FOR THE JO-LABOR & MATERIALS FOR THE PRINTING AND MATERIALS OF BUSINESS LEDGER CARDS

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


