A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFE DINER & CATERING SERVICES FOR THE MEALS & VENUE FOR THE BASIC INCIDENT COMMAND SYSTEM (ICS) TRAINING FOR TABACO CITY DRRM COUNCIL
