A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE SUPPLY & DELIVERY OF DROP CABLE FOR THE MAINTENANCE AND IMPROVEMENT OF SECONDARY FEEDER WIRES AT SAN VICENTE, TABACO CITY


