A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO GORILLA TRADING FOR THE SUPPLY & DELIVERY OF SCHOOL SUPPLIES FOR THE LIBRENG GAMIT SA ESKWELA PROGRAM, CITY MAYOR'S OFFICE, TABACO CITY UNDER CONTRACT ID NO. 019-06-2024-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of School Supplies for the Libreng Gamit Sa Eskwela Program, City Mayor's Office, Tabaco City under Contract ID No. 019-06-2024-GOODS* with an Approved Budget for the Contract (ABC) amounting to *Six Million Eight Hundred Fifty Thousand Pesos (Php 6,850,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on July 17, 2024, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Gorilla Trading*, the bidder with single calculated bid, which involves the verification and validation of its legal, technical and financial documents. It was found that *Gorilla Trading* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;


NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *GORILLA TRADING* as the Single Calculated Responsive Bid (SCRB) for the *Supply, & Delivery of School Supplies for the Libreng Gamit Sa Eskwela Program, City Mayor's Office, Tabaco City under Contract ID No. 019-06-2024-GOODS*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *GORILLA TRADING*, in the amount of *Six Million Eight Hundred Thirty Thousand Two Hundred Forty Pesos (Php6,830,240.00)*.


