A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE JO-LABOR & MATERIALS FOR THE REPAIR /REHAB OF MAYON PLANETARIUM AT BRGY. BUANG, TABACO CITY
