A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARIZAPA WELDING SHOP FOR THE SUPPLY, LABOR AND EQUIPMENT RENTAL FOR THE REHAB / REPAIR OF EVACUATION CENTER AT SAN ANTONIO, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-05-0572** with an Approved Budget for the Contract (ABC) of **Php 592,370.00**;
