A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JS ZAMORA CONSTRUCTION FOR THE JO-LABOR, EQUIPMENT RENTAL AND MATERIALS FOR THE URBAN GREENING PROGRAM AT TABACO CITY MALL FRONTAGE, TABACO CITY
