A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO D.A.B. POWER TOOLS & ELECTRICAL SUPPLY FOR THE SUPPLY & DELIVERY OF VARIOUS PUMPS FOR OPERATION AND MAINTENANCE AT CENTRAL MATERIAL RECOVERY FACILITY AND SANITARY LANDFILL FACILITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-05-0641** with an Approved Budget for the Contract (ABC) of **Php 171,550.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;
