**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO RRS MARKETING CORPORATION FOR THE SUPPLY & DELIVERY OF 1.5HP SPLIT TYPE AIRCON FOR KALAHI OFFICE**
