A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFE DINER & CATERING SERVICES FOR THE MEALS OF PERSONNEL WHO WILL ASSIST IN THE ROSTER OF ACTIVITIES OF TABAK FESTIVAL 2024

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-05-0662** with an Approved Budget for the Contract (ABC) of **Php 231,000.00**;
