A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO EBB CONSUMER GOODS TRADING FOR THE SUPPLY & DELIVERY OF FRESH EGG FOR 24-59 MONTHS OLDS UNDERNOURISHED CHILDREN
