WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:




WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a) To award the contract to **CASA VER AMORE INC.** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
